



## Unleashed Boarding Client Agreement

Unleashed Boarding (hereinafter “Unleashed”) is a cage-free environment where dogs socialize with other dogs in a group setting. Unleashed is a day camp and boarding facility for non-aggressive, socialized dogs; Unleashed is not a place for training your dog socialization behaviors.

While outside, dogs are encouraged to run and play in a safe manner while supervised by staff. As with any activity involving a group of dogs in an open area, there is risk of injury, exposure to contagious illness, and the potential to escape the supervised area. We take every precaution to reduce these risks but cannot completely eliminate them.

In the event of a medical emergency, we will make every effort to contact you before treatment is made. If we are unable to contact you, we will transport your dog to the veterinarian/hospital/clinic of our choice and follow the treatment plan of the consulting veterinarian.

- 1) **Disclosure:** By signing this Agreement, the undersigned Owner agrees to provide Unleashed Boarding complete and accurate health, behavior, medical information by filling out the “Initial Intake Form,” thereafter providing updated information verbally or in writing to Unleashed Staff, as needed. Owner verifies that the information provided to Unleashed is correct and accurate.
- 2) **Assumption of Risk:** Owner acknowledges and is aware that the employees of Unleashed are not veterinarians and do not have background in animal medicine. Owner understands that Unleashed Boarding is a cage-free, open play environment that allows dogs to be in close contact with one another. Owner understands that no amount of supervision, sanitation, or personalized care from Unleashed can prevent their dog from being injured, running away, contracting a virus or communicable disease, or death. Despite these precautions, Owner understands these risks inherent to the Services, and hereby releases Unleashed Boarding, it’s employees, agents, members from any and all losses, damages, costs, and expenses arising out of dog’s stay at Unleashed. This also applies to any claims or damages relating to medical care or transport provided by Unleashed.
- 3) **Assumption of Risk:** Owner acknowledges that when entering Unleashed Boarding, he/she is entering a cage-free dog environment. Owner releases Unleashed Boarding (employees, agents, members, heirs) arising from any injury caused while on the property, including but not limited to injuries caused by falling, slipping, objects, and/or dog bites or scratches.
- 4) **Medical Attention:** In the event of an injury, emergency or when Unleashed, in its sole discretion, deems medical care is important to the dog, Owner authorizes Unleashed to

obtain medical attention for dog. Owner grants Unleashed full power of decision making involving the medical treatment of dog (including transport and care to and from any agent) and agrees to pay for all costs associated with medical treatment. If the illness or injury requires medical attention, Unleashed will make every effort to contact Owner. Owner accepts responsibility for any and all associated expenses.

- 5) **Behavior:** Owner agrees to be solely responsible for any and all acts or behavior of dog while in the care of Unleashed, including cost of injury to staff, other dogs, and property caused by dog as determined by Unleashed. Owner agrees to indemnify Unleashed and its agents against any claims made against Unleashed or its employees, members or other agents, or losses or damages of any kind suffered by Unleashed or its agents as a result of Owner's failure to inform Unleashed of any pre-existing condition that the dog may have (such as illness, preexisting injury, or aggression problems) or which were otherwise caused by dog in the event that Unleashed is made a party to any lawsuit, arbitration, charge, or investigation relating to Owner's or Dog's actions, conduct, or Owner's failure to act. Owner shall indemnify, defend and hold Unleashed harmless from and against any and all claims, actions, causes of action, fines, penalties, costs or claims of loss of any type or nature which are attributable in whole or in part to Owner's or Dog's actions, conduct, or Owner's failure to act.

Owner agrees that Unleashed has the right to turn away, or refuse permission for dog to be allowed onto the property due to inappropriate behavior or if it is deemed risky or unsafe for other dogs. Owner waives action against Unleashed for such refusal.

- 6) **Photos:** Owner gives Unleashed permission to record, take, make photos, graphics, sounds, or other likeness of Dog; edit, copy, publish or distribute images; and use them in any of its publications, including website entries on Unleashed Boarding official site and other social media sites, without payment or consideration. Owner agrees that these materials become the property of Unleashed and will not be returned. Owner waives any right to royalties or compensation related to use of images.
